Relevant departments and areas of cooperation

The MOU is related to the following areas of academic and research activity.

1. 3D printing. Currently 3D is the rapid and accurate replacement technique for production of implant stents and cast partials and in the future more and more replacements are to come. Currently we have done cases and hope to also train students in this field.
2. Digital imaging. Conventional impression techniques have many drawbacks including inaccuracies due to dimensional change, patient discomfort and increased lab procedures. Currently digital imaging with intra oral scanners have reduced patient discomfort and used for fast processing of images and also useful to be used in patients with gag.
3. CAD CAM- computer aided designing and computer aided manufacturing for restoration like crowns, fixed partial dentures and zirconia crowns. Students can learn designing procedure for better understanding of CAD systems.
4. Laser sintered crowns –Implantology is new emerging and fast reaching treatment option and laser technology is able to give more accurate implant retained prosthesis. Student can have an opportunity to work with this technology.
