MEMORANUDM OF UNDERSTANDING
For OPD From CBCC Oncology Services Pvt Ltd

This Memorandum of Understanding (MOU) is executed at Chennai on this 20.03.2020, 2020 between

Dr.Rai-CBCC Oncology Services Pvt Ltd having its office at Saveetha Dental college campus, 162, Velappanchavadi, Poonamallee High Road, Chennai-600077 (hereinafter referred to as "CBCC", which expression unless repugnant to the context shall mean and include its successor-in-office, administrators and permitted assigns) of the **FIRST PART**;

AND

MADHA DENTAL COLLEGE & HOSPITAL, Chennai- 600069 (hereinafter referred to as MADHA DENTAL COLLEGE & HOSPITAL, which expression unless repugnant to the context shall mean and include its successor-in-office, administrators and permitted assigns of the **SECOND PART**.

(CBCC & MADHA DENTAL COLLEGE & HOSPITAL shall individually and collectively be referred to as 'Party' and 'Parties').

CBCC has established a state of the art Oncology Center at Velappanchavadi with latest Radiation Equipment installed to provide best available cancer treatment to patients of CHENNAI & surrounding areas and have discussed with MADHA DENTAL COLLEGE & HOSPITAL to extend Radiation Therapy /Chemo treatment to its Patients.

After both the parties mutual discussions, propose to enter into this MOU to set out their broad terms of understanding in this regard;

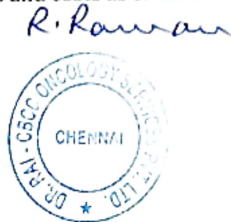
NOW THIS MOU WITNESSES AS FOLLOWS:

MADHA DENTAL COLLEGE & HOSPITAL shall refer Cancer patients to CBCC for radiation and chemotherapy as and when required.

1. A Multi disciplinary Tumour board shall be formed by doctors from **MADHA DENTAL COLLEGE & HOSPITAL** and CBCC. All patients diagnosed with cancer will undergo a consultation/discussion under the tumour board, to formulate treatment plan.
2. A reconciliation statement will be submitted to **MADHA DENTAL COLLEGE & HOSPITAL** by 10th of the subsequent month.
3. CBCC shall pay a referral sharing charges of 10% for patients treated under PM/CM/TPI Scheme and 25% on cash patient referred by **MADHA DENTAL COLLEGE & HOSPITAL**.
4. Referral amount shall be given on discharge and after recovery of amount from Scheme dept and cash by patients.
5. Referral amount shall be considered only for those patients, who are carrying a referral slip from the point of contact nominated by **MADHA DENTAL COLLEGE & HOSPITAL**
6. Both the party shall nominate a Point of contact for Coordination of patients transfer and treatment.
 - a. POC from CBCC Mr. R.Raman - Manager - Business Development-9944987138
 - b. POC from **MADHA DENTAL COLLEGE & HOSPITAL** DR. G. SIVAKUMAR
7. Both the parties hereby undertakes to maintain confidentiality for patient records ;
8. Each party shall be entitled to terminate the MOU by serving advance notices of THREE month.

INDEMNITY

CBCC shall be fully responsible for any claims damages etc, arising out of the services provided by CBCC to the **MADHA DENTAL COLLEGE & HOSPITAL** patient as per this MOU and agrees to indemnify and hold harmless of and from **MADHA DENTAL COLLEGE & HOSPITAL** any / all claim, demand, losses damages, lawsuits, judgment including attorneys' fees and costs as & when incurred WHILE ON TREATMENT in CBCC Premises .



ARBITRATION & JURISDICTION

Every dispute difference or question which may at any time arise between the parties hereto or any person claiming under them, touching or arising out of or in respect of this MOU or the subject matter thereof shall be referred to the common arbitrator to be appointed by the parties mutually and if the parties fail to appoint common arbitrator, one arbitrator shall be appointed by each party, if there is a difference of opinion between two said arbitrator, umpire shall be appointed by the said arbitrator and the decision of the said arbitrator or umpire shall be final and binding on the parties. This MOU shall be governed by and constituted in accordance with the law of India and it is agreed by and between the parties that any dispute differences, consequences or claims arising out of or relating to this MOU in subject to exclusive jurisdiction of courts at Chennai only.

VALIDITY

This MOU shall be valid for a period of 3 year from date of signing and can be renewed for further period as mutually agreed upon between the parties.
